COMMITTEE REPORT OF GRIEVANCE CELL

A grievance cell was constituted with Prof. Nanda Devi as coordinator and five other faculty members of the college during the session 2015-16 in order to redress the grievances of the college students.

The cell installed four complaint boxes in different places of the college campus for receiving complaints from the students if any. The cell used to open the boxes on monthly basis for finding solutions so that students' disadvantages are removed as early as possible.

During the session 2016-17, no grievances from the students was received.

During the session 2017-18, grievances for non-availability of pure drinking water and demanded provision for 24X7 supply of pure drinking water. The authority immediately responded to the need and took necessary steps.

In 2018-19, demand for renovation of Boys' Toilets was received and the authority made adequate provision for the same.

In 2019-20, application was received for street light facilities in the college campus and also for Girls' hostel. The grievance cell took up the matter with the authority and the facilities sought for were provided.

During the session 2020-21, demand for Girls' Common Room was placed by the students. The authority approached the Rabha Hasong Autonomous Council for a new Girls' Common Room and attached toilet facilities. Accordingly the new Girls' Common Room with toilet facility was constructed with financial aid from RHAC, Assam.

During the session 2021-22, demands for Dustbin to ensure cleanliness in the college campus and removal of inadvertent anomalies of class routine for the session 2021-22. Accordingly adequate numbers of dustbins were installed and the routine modified.


