### **HOW TO APPLY:-**

1. The filled up application must be submitted in Standard Form (published in the Gazette Part IX of Govt. of Assam) and accompanied by the following:-
  - i) Self-attested photo copies of testimonial/certificate in support of his/her age, caste, educational qualification, experience certificate (if any), employment exchange registration card etc.
  - ii) Three copies of recent passport sized coloured photographs with signature on the reverse side.
  - iii) Mobile Number along with E-mail ID (if any) must be mentioned in the Standard Form.
  - iv) The name of the candidate must be registered in the Employment Exchange and valid Employment Exchange Registration number is to be mentioned in the application form.

- v) The applicant has to furnish a self declaration certificate along with the application form mentioning that **he/she has not passed HSSLC or Class-XII or equivalent examination or above.**
- vi) Candidates already in Govt. Service must apply through proper channel along with "No Objection Certificate" from the appointing authority.
- vii) The envelope containing the application should mention the name of the Post indicating "**Application for the Post of PEON**" super scribed on the top of the envelop.

2. The applications in sealed envelope can be submitted through **post** or directly in the "**drop box**" of the office of the Chief Judicial Magistrate, Dhubri.
